#### ROLE OF STAFF REP (AM)

**BCTF** Facilitator

This workshop will prepare staff reps for their work with members in schools. Learn about the rights as a staff rep, how to represent members in initial conversations with school administrators, and become familiar with the format and content of the provincial and local Collective Agreement. Learn how to establish a network of support at the school and local level. This workshop will include role-playing, problem solving, and discussion to guide participants through all aspects of their role as staff rep.
